Terms of Use

User Agreement for Trillionpay Ltd.:

This Agreement applies to your use of Trillionpay Ltd.'s payment service and any related products and services (collectively the "Service").

In this Agreement, "you" or "your" means any person or entity using the Service ("Users"). Unless otherwise stated, "Trillionpay Ltd" will refer collectively to trillionpay.com, Trillionpay Ltd. and their respective parent or subsidiary companies, affiliates, officers, employees and agents.

Description of Services:

Eligibility:

To be eligible for an account,

- You must be a resident of any country and have a Bank account in that respective country
- You must register for an Account with Trillionpay Ltd
- If you are under the age of 18, you must obtain the consent of your parent or guardian.
- You must have access to the Internet and to a current e-mail address. You have sole responsibility for providing trillionpay.com with a correct and operational e-mail address.
